AEC FINANCIAL AGREEMENT

We understand that taking part in cheerleading is a big commitment both in terms of time and money. It is important that deadlines for payments are met and that anyone experiencing difficulties speak to Angela and set up a payment plan as early as possible within the season.

Anyone behind on payments will not be able to order spectator tickets to attend competition and watch their athlete compete or be given their competition uniform.

Any money paid for uniforms or spectator's costs will come off of any existing balance first if money is still outstanding. Some pre-loved uniform parts may be available to help with costs if needed, please see Paula if you would like more information on this. Failure to consistently to pay fees may result in the athlete losing their space on the team.

Financial Obligations

All athletes and parents understand that:

- Tuition fees do not fluctuate based on the number or duration of practices in any month.
- Tuition fees contribute towards training costs; tuition payment does not automatically earn the right to perform/compete.
- They assume full responsibility for all costs incurred as a member of AEC including but not limited to: registration fees, monthly tuition fees, practice clothes or any other items(s), competition and travel expenses or services rendered to me and the payment in full of those items or services regardless of any circumstances that may arise.
- All payment due dates must be met.
- An athlete's account must be current and in good standing to participate in practices, competitions or special events.
- AEC reserves the right to cancel any and all travel arrangements made that are not paid in full by the payment due dates.
- Any monies received from an athlete/parent will be applied first to any overdue fees/past unpaid bills.
- All fees must be up to date before an athlete may collect any clothing or other retail items.
- If an athlete chooses to leave or if asked to leave AEC for any reason before the season is over, any and all funds are completely non-refundable.
- AEC reserves the right to turn over all delinquent accounts to a collections agency and the parent/athlete will be responsible for all additional costs incurred.
